Section 889, Paragraph (a)(1)(A) of the John S. McCain National Defense Authorization Act (NDAA)

On August 13, 2019, Section 889 became effective. This paragraph prohibits federal agencies from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system, unless an exception applies or a waiver is granted.

Section A

Section 889(a)(1)(A) – or "Part A" – which took effect on August 13, 2019 – prohibits Executive Agencies from procuring or obtaining, or extending or renewing a contract to *procure or obtain*, "any equipment, system, or service that uses covered telecommunication equipment or services as a substantial or essential component of any system, or as critical technology as part of any system."

Section B

Section 889(a)(1)(B) – or "Part B" – which takes effect August 13, 2020 – prohibits Executive Agencies from entering into a contract, or extending or renewing a contract, with an *entity that uses* "any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system."

The effect of paragraph (a)(1)(B) is the US State Department can no longer make any purchases or place any orders on existing contracts until it is determined your company is in compliance with the ACT. In order for the US Department of State to make that determination, please complete the declaration/certification and return the undersigned with your quote.
